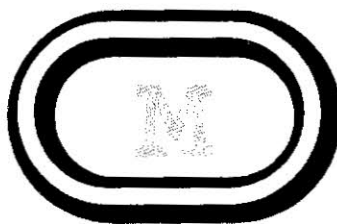

3. withdraw, cancel and/or delete any corporate names, transfer ownership of any and all domain names, trademark applications and/or trademark registrations for or including the Florida Shuttle Transportation, LLC;

Kindly govern yourself accordingly.

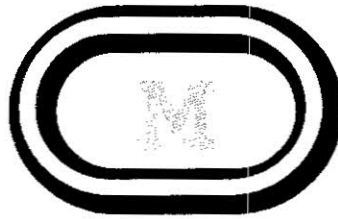

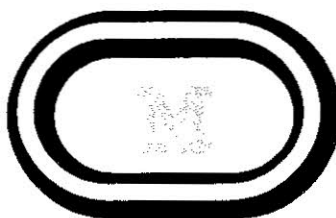
